New chemicals recommended to be used to control weeds for about 90 days forecast, 60 day probability. Chemical is stronger, pet friendly and environment friendly. Will be applied quarterly at cost of \$872 for main campus only). Cost comparison to be submitted to Mark Lewis for approval. Residents are seeing more weeds this year than in past not a difference in treatment but it's a difference in weather. Quote for lime treatment to be submitted to Joel for consideration. Map presented for rotating shrub trimming into five areas on rotation weeks for consideration to make more of a schedule that residents could follow. Will start seeding soon and apply some topsoil to deal with bald areas.

Work orders completed no report.

Trip Hazards no update Joel not at meeting due to sickness.

The curb pressure washing will continue, Scottish Rite Court completed in the rain and results look good. Board Meeting rumor about woodworking Shop not true. Cost worth the effort?? \$150,000 to retrofit the building.

## CAMPUS CARE ALLIANCE

### REPORT TO RESIDENTS COUNCIL

August 28, 2025

Campus Care Alliance's monthly meeting was held Tuesday, August 19 with 14 members, two guests and 8 staff members present.

For the second time a special ("coffee hour..jam session..meet and greet..get together.. take your pick...) was held an hour before our meeting began for some members of our committee and some nursing staff members from CWC. This informal setting is an opportunity an exchange of ideas, as well as just getting to know persons from the two communities by name and face. We will continue with this program as it does in fact demonstrate what the name of our committee speaks to.

Welcomed at our meeting were Rachel Seibert, the new CWC Director of Nursing; Ginger Cottrell, the new AL Manager; and Amanda Montgomery, the new CWC Assistant Director of Nursing.

Josh Hillegass reported that during the past month the average response time for call bells to be answered was down significantly and said, when asked, that the response time reported is in fact, when the task or request for that call has been taken care of. The number of falls during the month was up, but none of those required a trip to emergency room. The number of CARE awards has increased.

Karla Stapleton reported that there had been 17 Sara alerts answered in the past month. All were responded to by nurses....8 by CWC nurses, 7 by RHS nurses.

Discharge surveys (exit interviews) of WhiteStone residents who have spent time in CWS continue to be done and do provide a wealth of information about care being given there. Of note, delays in getting pain medication are a major concern for many of these persons. Exceptionally high marks are given for housekeeping services there.

The use of some form of identification worn by persons receiving care has been an ongoing concern expressed by many who believe that such will make medication administration less likely to be in error. On a motion by JoAnn Cox and by a majority vote of members present, CCA goes on record requesting and endorsing the use of id bracelets or some other means of id be worn by persons while residing in CWC. And that comparison of this ID is always to be made when medication is being administered to that person.

An internet report comparing WhiteStone to others in this geographic area (River Landing, Friends Home) which was based on the July 30 CMS report titled Nursing Home Resource Guide was discussed. Allen Greenstein asked that a special committee be formed to do an in-depth study of this and other surveys relating to WhiteStone--particularly from the standpoint of public relations for our community and their impact on prospective residents coming here.

At the Residents Advisory Council meeting on August 8 our report, outlining positive changes that are being made in CWC and the areas where work addressing some issues is still in progress was well received by the Masonic leadership, with assurances that they are also working on helping address the bothersome issues.

Allison informed the residents that August calendars and updated visitation lists were distributed in the in-house mailboxes. Allison discussed and distributed new "Sorry we missed You" cards. Larkin lightened up the color and made it easier to write on and read.

Don informed the committee members that the Auxiliary Committee usually doesn't meet in November and December. The committee will vote on this at a later meeting. In addition, the committee members will need to determine the chair for next year.



Old business discussions included:

Glass Recycling- much discussion on opportunities to improve our glass recycling efforts including have Wine Down staff pack empty bottles in boxes for easier transportation, committee member Frances Cooper will remind Committee volunteers of their time slots for transportation to glass recycling bins. Concerns were discussed about difficulty of committee members safely moving heavy containers of glass.
