## WEGI Report to Resident Council on 09/25/2025

The WEGI Board of Directors is pleased to update the Resident Council on our fundraising efforts for the year. To date, we have raised nearly \$10,000 in donations, which represents 10% of our annual goal of \$100,000. These funds will be distributed to qualified Staff Members during the week before Christmas.

Our formal fundraising campaign is scheduled to begin on November 3rd and will run through November 28th. We encourage all residents to participate and help us reach our goal.

We invite residents to attend our upcoming informational meetings in the Fellowship Hall. The meetings will take place on Monday, October 27th at 3:00 PM, and Tuesday, October 28th at 10:00 AM. During these sessions, attendees will have the opportunity to view a special video produced by WhiteStone. Please be sure to mark these dates on your calendar.

We continue to receive wonderful gifts that will be raffled among all residents who contribute to this year's fundraising campaign. The raffle items are sure to excite, so we encourage everyone to make a contribution as soon as possible to be eligible for these prizes.

## What's So Special About WEGI?

- WEGI (WhiteStone Employee Gratitude Initiative) is a resident-managed program established in 2024 to provide monetary awards to eligible WhiteStone employees.
- Since personal gifts of money or property to employees are prohibited, WEGI provides an equitable and risk-free way for residents to show appreciation.
- Funding for WEGI comes from ongoing contributions by residents, their families, and friends, collected monthly or during a dedicated campaign in November.
- All funds raised are exclusively used for awards to staff members in good standing; both full-time and part-time staff qualify, except those in leadership roles.
- Eligibility for awards is based on hours worked from November 1 to October 31, and staff must be employed as of December 1 to receive the award.
- The Human Resources department calculates eligible hours, determines each recipient's share, and distributes monetary awards separately from regular pay during the week before Christmas.
- Each award recipient receives a letter from the WEGI Board of Directors expressing gratitude for their service.
- Residents, families, and friends donate art prizes for an auction held at Wine Down, the first Friday after New Year's Day, with campaign contributors receiving raffle tickets for a chance to win those prizes.
- The Board of Directors express deep gratitude to residents for generous donations which demonstrates profound appreciation for services performed by our dedicated staff members.

### Brightview:

# Campus Care Alliance Report for Sep 2025 Resident Council

Cathy

We had our monthly meeting on September 16<sup>th</sup> at 10:30 in the Education Center. For those of you who might not know, it is located in the Lower Level of the Assisted Living building. It was attended by 9 Alliance members, and 8 WS staff.

Our monthly presentation was given by Leonard Miller, our Director of Environmental Services. It was an outstanding talk that included the work of his housekeeping staff in the Care and Wellness Center, how they show the CCA ideal of person-centered care, and the extensive steps taken for infection control.

Cathy Long prepared and gave us a brief talk about her study of the Nursing Home Resource Guide.

Teams of 2 staff members have been in place the last few weeks for showering residents in the CWC who need assistance. We will continue to learn about the progress of the team concept of care also.

We have supported the idea of having a WS-wide presentation developed for the medication procedures in the CWC. This is an issue that is often brought up by independent residents who spent time in the CWC and returned to their residences. Residents in general have concerns about their medications in case they will need medical help in the future. Mark and Josh are receptive to working with us and the staff on this project. A possible date will be in November.

Josh Hillegass and Karla Stapleton gave their reports on call lights, falls, Care awards, and SARA alerts. For example, there were 6000 call lights in the CWC last month, with a response time on average of 5 ½ minutes. Response times are measured from when the call bell is used and when the need is resolved by staff. This is a great improvement due to use of the new pager system, more staff training, and having a full complement of nursing leadership on board.

Josh and the new DON, Assistant DON, and AL manager and a few others met recently to discuss strategic initiatives. These are complaint resolution to increase resident satisfaction, quality measures for person-centered care, and an annual orientation and education program for the staff.

We have noticed there is not always sanitizer in the dispensers located near elevators. This is needed especially during flu and COVID season. We urge you all to use hand sanitizer in our buildings.

In closing, Cathy and I would like two of our members to volunteer to help conduct our post-discharge interviews with IL residents who went to the CWC, and then returned to their homes and apartments. Please email or talk to us after the meeting if you are interested.

Don opened up the meeting and greeted the committee and thanked the committee for their hard work.

Jill Jones prayed with the committee.

Don introduced Eleanor Drake to the committee as an individual who is interested in the group.

Josh Hillegass introduced Marline to the group as the Resident Relations Specialist. Marline's focus is resident and family satisfaction in AL and CWC. Josh informed the committee of her new schedule, Monday/Wednesday/Friday/Saturday/Sunday to provide support. Josh updated the committee on covid positive cases; two cases in CWC and nine cases in AL. Josh informed we are working to stop the spread by wearing masks at this time. Josh stated that we are not stopping visitations but not to visit if you are not feeling well. Josh informed the members that they can still work the CWC Front Desk and visit, but if they do not feel comfortable, that is understandable and up to the member.

William and Josh informed the committee of the new sign in system for CWC guests. William informed the committee that the new sign in system is still a work in progress. The guests will put in their phone number or email when signing in. They click the link sent to their email or texts to sign out. There is also a small icon on the top right to sign out on the actual device. William is working on printing instructions for this new device. A guest's phone number will be saved so they do not have to re-enter their information. The system will ask who the guest is here to visit. The system prints off a label for the guest to wear. This check in system is primarily for guests, and committee members will continue to use the sign in books behind the desk. Alicia stated that some families are pleased with the new system. Josh informed that each guest needs to sign in to get an accurate head count.

Alicia Sharp asked Josh the appropriate way to approach guests who do not want to wear a mask or families who ask questions. Josh informed the committee to get a nurse for assistance.

Eleanor Drake asked where masks can be found. Josh informed the committee members that masks will be located at the intersection of AL/CWC and at the front of the CWC entranceway.

Don passed around sign in sheets for October. Don informed the committee that we do not meet in November and December so next month they will be signing up for multiple months. Don encouraged committee members to attend the next meeting. Jill encouraged the committee to

wear their name tags and purple vests when volunteering at the front desk. This indicates that they work for the Auxiliary Committee and it sets them apart from aids/nurses.

Allison thanked the residents for all their assistance and support with the CWC and AL residents. Allison informed the committee that September calendars were distributed into the in-house mailboxes last week. Allison informed the committee that October calendars will be distributed to in-house mailboxes. Allison will bring new/updated visitation lists and upcoming events lists to the next meeting.

Archana asked why there are two Auxiliary Committee books at the check-in location. Jill stated that one has guidelines/regulations and the other book is a sign in book. Archana suggested to consolidate into one book. Allison suggested to add it to the visitation list. Committee agreed to consolidate into one book and if problems arise, we will fix it.

Archana mentioned upcoming events such as the AL/CWC cookout on September 27 during lunch time. Archana informed the members that the cookout is a time to assist the AL/CWC residents to fill out their resident satisfaction surveys. The time is from 12:30-2:00 pm. It will be held near the Fitness Room portico.

Alicia, Jill, Don, and Josh discussed independent living residents who are currently in the hospital.

Gina Prevost mentioned the upcoming event, "Oktoberfest." There are ninety RSVP's so far. Gina mentioned that it will occur on September 24<sup>th</sup> from 4:00-6:00 pm.

Don thanked the committee for their time and dedication to assisting and visiting residents in AL/CWC.

Jill Jones asked if there is an uptick of illness, if visitation will stop. Josh will communicate to the committee if they should not visit and/or assist.

October 29 is the vaccination day on campus for Covid/Flu. More information will come.

Don will contact those members who are not here to complete the sign-up sheet for October.



# Resident Services Committee Meeting

9.8.2025

The meeting covered updates on the upcoming vaccine clinic, resident satisfaction surveys, internet connectivity issues, environmental services, and other resident-related concerns. The discussion emphasized coordination for vaccine consent, scheduling, and addressing service improvements across the community.

- **Vaccine clinic scheduled:** The vaccine clinic is set for October 29th with a staggered schedule by campus area. Consent forms including insurance information are required, and Moderna will be the primary vaccine offered with limited Pfizer availability. Residents can coordinate with Kaylee for RSV shots or makeup vaccine appointments.
- **Vaccine eligibility and procedures:** Residents must be at least eight weeks post-COVID infection and three months since their last vaccine dose to receive the updated vaccine. Pharmacists will monitor for reactions post-vaccination, and home visits can be arranged for residents unable to attend the clinic.
- **Internet and connectivity issues:** Some residents reported slow internet speeds and intermittent connectivity, affecting streaming and printing. Efforts are underway to monitor and improve service, including checking channel switching and device impacts.

The Chapel WiFi continues to be an issue during Sunday streaming for the residents. The location of the access point has been identified as the problem. Relocating the access point should help to resolve the problem.

- **Resident satisfaction surveys:** Surveys will begin on the 16th, aiming for broad participation with events planned to encourage completion. The surveys are anonymous and confidential, with support available for those needing assistance.
- **Environmental services updates:** Discussions included moving environmental services under a new committee and recognition of the team's efforts to improve cleanliness and resident support. New initiatives will be announced soon.
- **Additional resident concerns:** Topics such as pet policy enforcement, carpet cleaning, and a research article on nasal sprays reducing COVID frequency were briefly discussed, reflecting ongoing community engagement and information sharing.

5. We were unable to have an update on how recycling efforts are going in the Dining Room and Bistro.

New Business:

1. Labeling for the Rotunda and WineDown will be handled by Larkin and Archana.
2. Posters advertising glass recycling will be made and distributed.
3. Styrofoam recycling will not be part of Whitestone's residential buildings at this time.

Other Business:
