INVESTMENT POLICY STATEMENT

WhiteStone: A Masonic and Eastern Star Community August 2019

ENDOWMENT FUND

Introduction

The purpose of this Investment Policy Statement is to assist the NC Masonic and Eastern Star Home Inc, dba WhiteStone: A Masonic and Eastern Star Community (WhiteStone) in effectively supervising, monitoring and evaluating the management of WhiteStone's Endowment Fund (EF).

The investment policy statement will:

- 1. Define the role of the Finance Committee (Committee) with respect to overseeing investments and outline delegation of authority and responsibility.
- 2. Establish expectations, objectives and guidelines in the investment of the Fund's three primary areas of assets.
- 3. Identify within each asset area, allocation policy, diversification, liquidity, risk tolerance, time horizon, rebalancing and monitoring of performance.

Mission

WhiteStone: A Masonic and Eastern Star Community is a continuing care retirement community whose mission is "United as a retirement living leader since 1912, we are devoted to excellence in hospitality with traditional values promoting fraternal service, dignity, dependability and choice."

Statement of Objectives

- 1. Maintain the purchasing power of the current assets and all future contributions
- 2. The desire of Whitestone is to maintain the level of programs and services currently provided. This can only be accomplished if sufficient total return is reinvested and new funds added to keep pace with cost increases and program expansions.
- 3. Maximize return within reasonable and prudent levels of risk.
- 4. Maintain an appropriate asset allocation based on a total return policy that is compatible with a flexible spending policy, while still having the potential to produce positive real returns.

Time Horizon

The investment guidelines for the Endowment Fund are based upon an investment horizon of greater than ten years. Therefore, interim fluctuations should be viewed with appropriate perspective

Performance Expectations

In general, WhiteStone would like the EF to earn a long-term return of 4% greater than the rate of inflation as measured by the CPI.

Risk Tolerance

The investment policy statement will:

- 1. Define the role of the Finance Committee (Committee) with respect to overseeing investments and outline delegation of authority and responsibility.
- 2. Establish expectations, objectives and guidelines in the investment of the Fund's three primary areas of assets.
- 3. Identify within each asset area, allocation policy, diversification, liquidity, risk tolerance, time horizon, rebalancing and monitoring of performance.

Statement of Objectives

- 3. Maximize return within reasonable and prudent levels of risk.
