



Dear WhiteStone Resident,

At the end of the campaign for 2025 on November 30th, **72.5%** of the residences made contributions that will be distributed to our dedicated staff the week before Christmas! Residents gave **144** gifts totaling **\$82,685.20** and non-residents gave **10** gifts totaling **\$2,850.00** which amounts to **\$85,535.20**. That is an increase of **\$20,973.20** or **32.5%** over 2024 contributions. Some residents contributed more than one donation this year. After consolidating those extra gifts, the average donation was **\$555.42** per gift. The following tables represents the breakdown of all donations.
